<p>Description: General Motors has decided that a defect which relates to motor vehicle safety exists in model year 2005-2007 Chevrolet Corvette vehicles. On these vehicles, when the engine is warm, the underhood bussed electrical center (UBEC) housing will expand, causing the headlamp low-beam relay control circuit routed wire to bend slightly. After the wire is repeatedly bent, it can fracture and separate. When this occurs, the low-beam headlamps will not illuminate. As the UBEC housing cools and contracts, the low-beam headlamp function may return. This condition does not affect the high-beam headlamps, marker lamps, turn signals, daytime running lamps or fog lamps.</p> <p>Loss of low beam headlamps when they are required could reduce the driver's visibility, increasing the risk of a crash.</p> <p>Remedy: Dealers are to replace the UBEC.</p>

Glossary

First Owner

When the first owner(s) obtains a title from a Department of Motor Vehicles as proof of ownership.

New Owner Reported

When a vehicle is sold to a new owner, the Title must be transferred to the new owner(s) at a Department of Motor Vehicles.

Ownership History

CARFAX defines an owner as an individual or business that possesses and uses a vehicle. Not all title transactions represent changes in ownership. To provide estimated number of owners, CARFAX proprietary technology analyzes all the events in a vehicle history. Estimated ownership is available for vehicles manufactured after 1991 and titled solely in the US including Puerto Rico. Dealers sometimes opt to take ownership of a vehicle and are required to in the following states: Maine, Massachusetts, New Jersey, Ohio, Oklahoma, Pennsylvania and South Dakota.
